#### **GENERAL INSTRUCTIONS**

SLUGGIT PRIMA 30 bait has a stomach and contact action in slugs and snails that induces heavy secretion of mucous with the consequence that slugs and snails die in a reasonably short time from dehydration. SLUGGIT PRIMA 30 bait is particularly active against molluscs. If the product is applied according to the directions for use, non-target organisms will not be affected. Addition of a bittering agent has made SLUGGIT PRIMA 30 bait distasteful to mammals and birds. Best results are achieved by application after rain, watering or during damp and humid weather when the slugs and snails are most actively seeking food but not when rain is imminent. Scatter bait evenly using an appropriate applicator by ground or air, or direct drill with seed for slug control. Clean up spilled bait after filling applicator or whenever the bait is spilt.

#### **PRECAUTIONS**

DO NOT use human flaggers/markers unless they are protected by engineering controls such as enclosed cabs.

#### PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the product or used containers.

#### PROTECTION OF DOMESTIC ANIMALS AND LIVESTOCK

Keep away from animals, poultry, ducks and domestic pets as accidental poisoning may be fatal. DO NOT graze or cut for stockfeed any area while SLUGGIT PRIMA 30 bait is visible in the plant foliage. If pets or livestock are poisoned, contact a veterinary surgeon.

## STORAGE AND DISPOSAL

Store in the closed original container in a dry, cool, well ventilated area out of direct sunlight. **STORE IN A LOCKED ROOM OR PLACE OUT OF THE REACH OF CHILDREN, ANIMALS, FOOD, FEEDSTUFF, SEED AND FERTILISERS.** Shake and empty contents into application equipment. Do not dispose of unused product on site. Break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

## **SAFETY DIRECTIONS**

When opening the container and loading and if applying by hand, wear cotton overalls buttoned to the neck and wrist (or equivalent clothing) and elbow-length rubber gloves. After each day's use, wash gloves and contaminated clothing. Wash hands after use.
